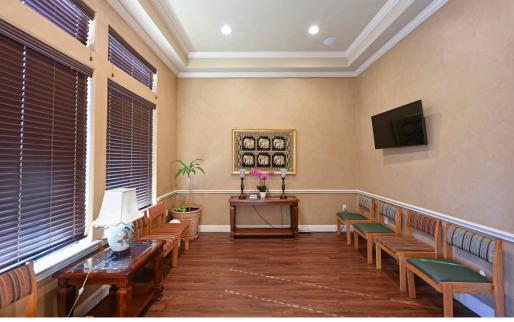

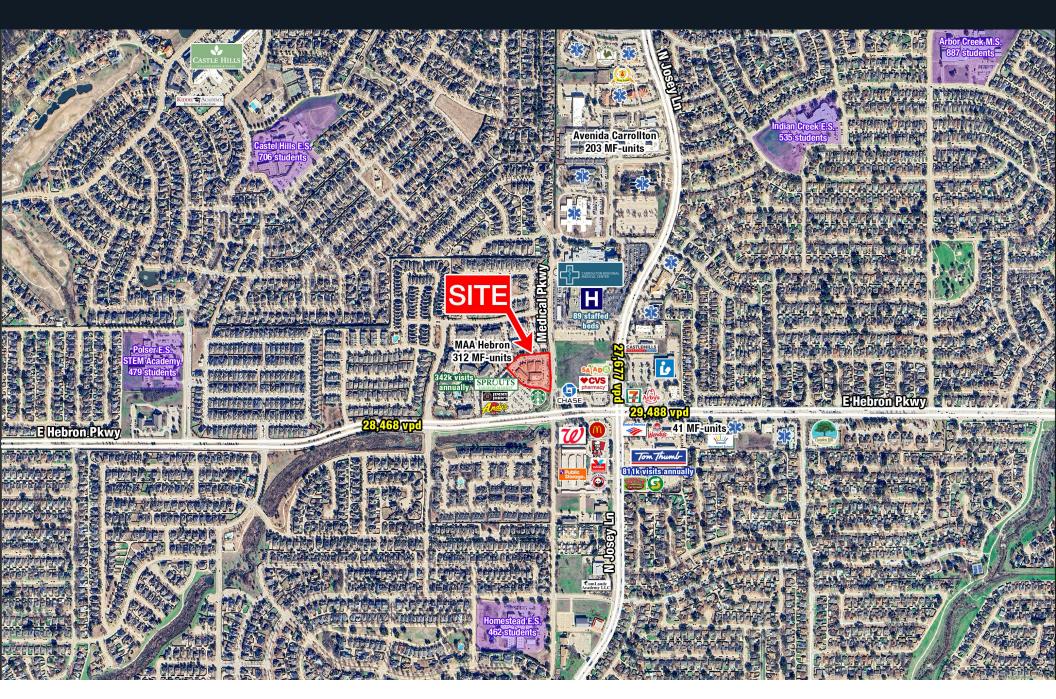
FLOOR PLAN

INFORMATION ABOUT BROKERAGE SERVICES
